## **THE SCHEDULE OF APPROVAL**

### **1. PRODUCT DESCRIPTION:**

#### **A-60 Steel Bulkhead "FireMaster Marine Plus Blanket, 60 mm x 80 kg/m<sup>3</sup>"**

Structural bulkhead insulated with "FireMaster Marine Plus Blanket", 60 mm thick, density 80 kg/m<sup>3</sup>.  
Applied laterally in between and around the stiffeners in strips of 600 mm width.  
Packing is required in the stiffener cavities.

Fastening arrangement : steel pins / washers

Pins spacing :

- max 300 x 350 mm between stiffeners
- max 180 mm from stiffeners

The installation is to be performed according to the manufacturer's documentation referenced in §2.

### **2. DOCUMENTS AND DRAWINGS :**

### **4. APPLICATION / LIMITATION:**

4.1 - The insulating material "FireMaster Marine Plus Blanket" shall comply with the requirements of relevant Bureau Veritas Rules and be type approved.

4.2- The fitting aboard to be the same as used for the test.

### **5. PRODUCTION SURVEY REQUIREMENTS:**

5.1- The **A-60 Steel Bulkhead "FireMaster Marine Plus Blanket, 60 mm x 80 kg/m<sup>3</sup>"** is to be supplied by **Morgan Advanced Materials Thermal Ceramics** in compliance with the type described in this certificate.
